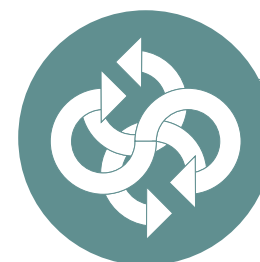

WASPI CODE OF CONDUCT CONSULTATION LAUNCH

Over the last three years, work has progressed on transitioning the Wales Accord on the Sharing of Personal Information (WASPI) framework into a potential Information Commissioner's Office (ICO) Code of Conduct.

The intended code builds upon the existing framework with the intention of offering members and their stakeholders, including the public, additional assurance around organisational practices of data sharing.

We want your views on the proposal for the WASPI framework to apply to become an approved Information Commissioners' Office (ICO) Code of Conduct under the provisions of article 40 of the UK General Data Protection Regulation.

This consultation sets out how the WASPI framework applying to become an approved ICO Code of Conduct would enhance the existing controls with increased application and consistency of data sharing activities as well as providing an assurance accountability of good governance.

The WASPI team has planned a full consultation, highlighting key forums, networks and targeted audiences who will be engaged for their views on the proposed code during the consultation period which runs until 28th April 2023.

Please provide your responses. These will shape the development of the proposed WASPI Code of Conduct and support any application to the Information Commissioners' Office.

Thanks to our guest speakers from the Information Commissioner's Office, Blake Morgan and Welsh Government, and to everyone who took the time to attend.

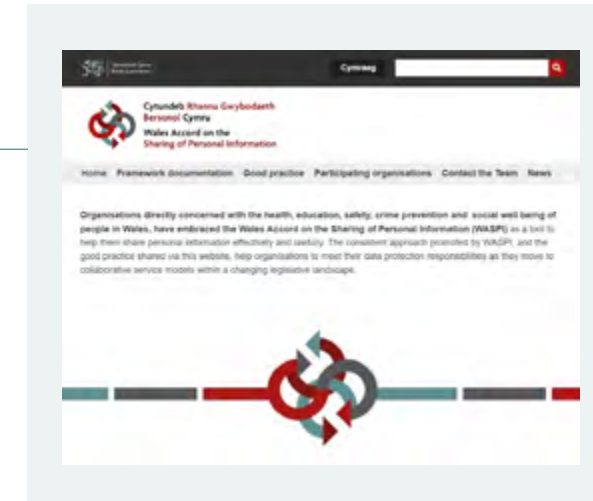
Fantastic feedback was provided from attendees which will form part of the consultation process and help shape final decisions on our proposals.

WASPI COVID-19 TEMPORARY ISP FEEDBACK

Thank you to everyone who took the time to reply to our survey regarding the WASPI COVID-19 Temporary Information Sharing Agreement template which was produced proactively by the WASPI team to support stakeholders' information sharing during the pandemic.

The survey responses support the benefits the template provided for stakeholders, providing organisations with a standard approach that created consistency, allowing stakeholders to document their data sharing activities quickly, and therefore focus other time on other urgent matters required during the pandemic.

The WASPI framework played a pivotal role in supporting documented data sharing throughout the covid-19 pandemic, with Wales being the only UK nation to have consistent documentation to support data sharing arrangements supporting citizens. A recent report from the Institute of Government, “Data sharing during coronavirus: lessons for government” holds up WASPI as an area of good practice.

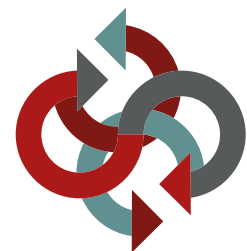
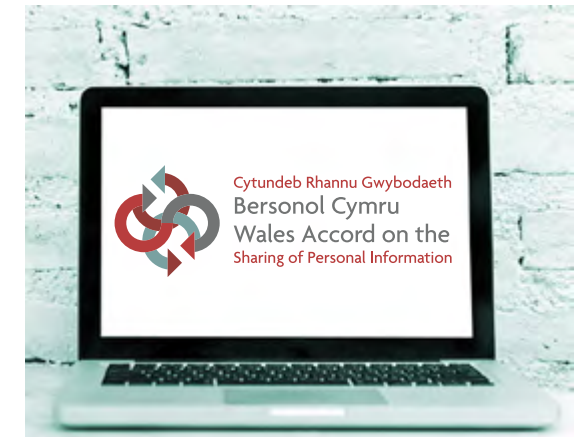
