## **WASPI UPDATE**

### **WASPI Data Processor and Joint Controller Agreement Templates now available:**

We are delighted to have released two new WASPI templates to support organisations with data processor and joint controller arrangements.

We have developed template Data Processing Agreement and Joint Controller Agreement documents and supporting guidance for each.

These are designed to support a range of organisations and are fully flexible as they are not subject to any WASPI quality assurance processes.

The templates have been developed in partnership with Blake Morgan LLP, with English and Welsh versions of these available on our [website](#).

## **WASPI CODE OF CONDUCT CONSULTATION UPDATE**

Work continues on the proposals for a WASPI ICO Code of Conduct. The WASPI team are working with colleagues from the Information Commissioner's Office on the next steps for the potential submission for formal consideration of the proposed Code, with systems and proposes which will support any code monitoring body being actively developed.

## INFORMATION SHARING GATEWAY UPDATE

---

The development of the Information Sharing Gateway (ISG) system continues to progress. Following successful workshops with pilot organisations earlier this year, a number of requests for change and alterations were identified. Work is ongoing with developers over the coming months to make changes to the system following feedback received.

Work has begun on uploading of Information Sharing Protocols into the system. Organisations are asked to review any existing agreements that they may have on older versions of WASPI templates, and work towards updating these over the coming months to aid the planned migration of all ISPs onto the system over the remainder of the year.
