WASPI CODE OF CONDUCT CONSULTATION UPDATE

Further to our proposals and request for views for the WASPI framework to apply to become an approved Information Commissioners' Office (ICO) Code of Conduct, the report on the consultation undertaken has now been published.

The WASPI Team and Blake Morgan LLP have made some amendments to the WASPI Data Processor and Joint Controller Agreement templates following feedback received from stakeholders. Guidance associated

with the templates are currently being produced with a view to these being published alongside the templates shortly. Look out for further information in the coming weeks.

It is anticipated that further developments will be made to the system over coming months following conclusion of the workshops and we will keep stakeholders updated on progress over the coming months.
