

WASPI UPDATE


Welcome to our new digital WASPI newsletter.

WASPI continues to grow from strength to strength with continuing uptake from organisations across Wales signing up to the Accord.

A landmark was recently reached with our 750th organisational sign up!

Our new digital newsletter aims to provide easier access to information and tools which you can reuse within your organisations, with the intention to provide video tutorials which you can re-use as training materials, supporting organisations and your staff with better understanding of the WASPI values and processes.

To further improve transparency, our 5 regional quality assurance groups have recently agreed a set of standards to be adopted during the autumn, these include the **publication of planned regional meetings** which we anticipate will improve transparency and support all of our partners.

WASPI STRATEGY

WASPI Strategy 2022-2025 now published

An updated **WASPI Strategy** has been published, details of which can be found on our website.

This builds upon the 2020-2025 strategy and reflects upon the benefits the WASPI framework has had in supporting partners through the covid-19 pandemic as well as through ongoing initiatives including the Ukrainian resettlement programme.

The three-year strategy focuses on the aims of WASPI to become an approved ICO Code of Conduct and developing digital tools to support partners with the end to end process of creating and maintaining ISP's.

WASPI CODE OF CONDUCT

WASPI continuing to move forward with its intention to become an ICO approved Code of Conduct

The WASPI Team and Digital Health & Care Wales continue to work with the ICO Code of Conduct team in developing WASPI as a potential ICO approved Code of Conduct.

The aim of the code would be to build on the existing WASPI framework to address key risks that threaten organisational compliance with the WASPI principles and the effective and lawful sharing of personal data.

Code of conduct requirements would offer code members and their stakeholders, including the public, additional assurance around organisational practices of data sharing.

It is intended that organisations signed up as code members would benefit from additional level of assurance and controls which could mitigate risks for organisations if subject to action from the Information Commissioner.


Look out for further announcements on the development of the WASPI Code of Conduct and planned consultation over the coming months.
